General Safety Information

- Verify that supply voltage is correct by comparing it with the luminaire label information.
- Make all electrical and grounded connections in accordance with the National Electrical Code and any applicable local code requirements.
- All wiring connections should be capped with UL approved wire connectors.

- Wear gloves and safety glasses at all times when removing luminaire from carton, installing, servicing or performing maintenance.
- Avoid direct eye exposure to the light source while it is on.
- · Account for small parts and destroy packing material, as these may be hazardous to children.

General Wiring Diagram


CAUTION: Turn off electrical power at fuse or circuit breaker box before wiring fixture to the power supply.

Connecting fixture to AC source supply:

All units must be individually connected to the AC supply. (see page 1 for voltage by model)

Black = Line White = Neutral





AC wiring instructions

- Connect supply wires to quick connect supplied: Black/Hot supply to quick connect with black wire. White/Neutral supply to quick connect with white wire. Confirm connections are secured.
- 2. Connect ground wire to quick connect with green wire. Confirm grounding connection is secured.

Installation & Operation

▲WARNING

Disconnect the power by turning off the circuit breaker or by removing the appropriate fuse at the fuse box. Turning the power off using the light switch is not sufficient to prevent electrical shock.

- 1. Use a screwdriver to loosen (2) screws securing fixture cover. Remove fixture back plate from fixture.
- 2. Use Philips screwdriver to slide wire way covering from back plate of housing.
- 3. Use 1" thread ½ NPT fitting (not supplied) through back of housing until flush with outside surface.
- 4. Add ¼" bead of exterior grade silicone sealant around the perimeter of the wall pack.
- 5. Feed power leads from junction box through NPT fitting into the exterior of the fixture.






- 6. Continue screwing NPT fitting into Junction box until fixture back plate is tight to mounting surface.
- 7. Lock NPT fitting in place with ½" NPT (not supplied.)
- 8. Reattach fixture front to fixture back plate.
- 9. Connect driver OUTPUT leads to quick connect originating from LED array. Red output to quick connect with red wires, black output to quick connect with black wires.
- 10. Reattach fixture using two Philips head screws.

Warranty

LIMITED WARRANTY FOR CERTAIN MAXLITE® LED LIGHTING FIXTURES, SPECIFICALLY WALL PACKS; FLOOD LIGHT; AREA LIGHT; CANOPY; GARAGE; PARKING; SECURTIY LIGHT; VAPOR TIGHT AND ROADWAY.

This limited warranty is provided by the MaxLite company described below ("Seller") to you as the original purchaser of the LED lighting product that is identified on Seller's invoice reflecting its original purchase (the "Product"). The Seller is the MaxLite Company identified as such on the invoice. This limited warranty may be transferred to subsequent purchasers of the Product, provided that such Product is resold in new condition and in its original packaging. Seller warrants that the Product, when delivered in new condition and in its original packaging, will be free of defects in material and workmanship for a period of FIVE (5) YEARS from the date of original purchase or the number of hours used has not exceeded the L70 life stated for each LED fixture. The determination of whether the Product is defective shall be made by Seller in its sole discretion with consideration given to the overall performance of the Product. A Product shall not be considered defective solely as a result of the failure of individual LED components to emit light if the number of inoperable components is less than 10% of the total number of LED components in the Product.

If Seller determines the Product is defective, Seller will elect, in its sole discretion, to refund you the purchase price of the Product, repair the Product or replace the Product. This limited warranty does not apply to loss or damage to the Product caused by: negligence; abuse; misuse; mishandling; improper installation, storage or maintenance; damage due to fire or acts of God; vandalism; civil disturbances; power surges; improper power supply; electrical current fluctuations; corrosive environment installations; induced vibration; harmonic oscillation or resonance associated with movement of air currents around the Product; alteration; accident; failure to follow installation, operating, maintenance or environmental instructions prescribed by Seller or applicable electrical codes; or improper service of the Product performed by someone other than Seller or its authorized service provider. This limited warranty excludes field labor and service charges related to the repair or replacement of the Product. THIS LIMITED WARRANTY IS VOID IF THE PRODUCT IS NOT USED FOR THE PURPOSE FOR WHICH IT IS DESIGNED.

Seller reserves the right to utilize new, reconditioned, refurbished, repaired or remanufactured products or parts in the warranty repair or replacement process. Such products and parts will be comparable in function and performance to an original product or part, as determined by Seller in its sole discretion, and warranted for the remainder of the original warranty period.

In order to make a warranty claim, you must notify Seller in writing within sixty (60) days after your discovery of the defect, provide proof of purchase such as the invoice and comply with Seller's other warranty requirements. Upon receiving that notice, Seller may require you to promptly return the Product to Seller, or its authorized service provider, freight prepaid.
